ROAD MAINTENANCE PROGRAM 2015

Open 2015 Asphalt Bids – Steve Seeds of APTech prepared the scope of work and RFP (request for proposal) and requested bids from 6 vendors. Five vendors returned bids: Apex Grading & Paving, Telfer Highway Technologies, Inter Mountain Slurry & Seal, Sierra Nevada Concrete (SNC) and West Coast Paving. The bids will be analyzed and summarized by Steve Seed with recommendations to the board at the April 14, 2015 meeting.

FUELS MANAGEMENT GRANT WORK 2015

Open 2015 Fuels Management Bids – Rodd Rummel of High Sierra Forestry prepared the scope of work and RFP and requested bids from 3 vendors. Only one bid was received, The Paul Roen Company for a cost of \$71,312.50. This is well under the \$100,000 budget. Since this was the only bid received, Rod recommends approval. The formal approval by the board will take place at the April 14, 2015 meeting. Discussion ensued about the grant areas.

HOMEOWNER COMMENTS

W. Krachun – Would like the board to pay more attention to communications going out to the members. There have been letters that could have been more clear. He also asked why the board is still waiting on the FOA. M. McConnell – Confused by the actions of the board about golf. Is the board pursuing golf?
