An owner may record on audiotape or any other means of sound reproduction a meeting of the executive board if the owner, before recording the meeting, provides notice of his or her intent to record the meeting to the members of the executive board and the other units' owners who are in attendance at the meeting. - 2. <u>Homeowner Comments</u>: Owners have the right to speak to the Board. This period is devoted to comments related to agenda items from property owners and discussion of those comments. Please note that the Board may limit the time for individual comments. A time limit of three minutes has been allotted per owner. No owner can give away their allotted time to expand another owner's time.
- 3. <u>Discuss a Golf Proposal Between the ArrowCreek HOA (ACHOA) and Friends of ArrowCreek (FOA)</u> Receive a report and recommendations from the ArrowCreek Community Club (ACCC) Committee regarding a potential business arrangement with the Friends of ArrowCreek (FOA), which may require the Board to pass a resolution to initiate a community wide vote on a Ballot Proposition concerning the business arrangement. Action.
- 4. <u>Homeowner Comments</u>: Owners have the right to speak to the Board. This period is devoted to comments by units' owners and discussion of those comment about any matter affecting the community. Except in emergencies, no action can be taken upon a matter raised unless the item is specifically included on the agenda. A time limit of 3 minutes is allotted per owner.
