An owner may record on audiotape or any other means of sound reproduction a meeting of the executive board if the owner, before recording the meeting, provides notice of his or her intent to record the meeting to the members of the executive board and the other units' owners who are in attendance at the meeting. An Executive Session of the Board will be held prior to, the board meeting to discuss CCRs violations, please see separate agenda (executive session is board members only). No owner can give away their allotted time to expand another owner's time.
- 3. <u>Selection of Board Officers & 2016 Meeting Calendar</u>: The board meeting following the annual members meeting for the selection of officers was not properly conducted to provide for homeowner input. Therefore that meeting is void and the board will select officers and review the 2016 meeting calendar at this meeting.
- 4. Informational Documents for the Golf Ballot Vote:
  - Approval to sign the Real Property Purchase, Sale and Lease Back Agreement for Purchase of the Golf Course
  - Approval of the draft CCRs and Bylaws changes with golf to be sent with the informational packet
  - Approval of the draft ballots to be mailed for owner approval of the amended CCRs and Bylaws and the encumbrance to purchase the golf course
  - Approval to mail the informational packet to the homeowners and review of the proposed schedule of events for the ballot voting process
- **Homeowner Comments**: Owners have the right to speak to the Board. This period is devoted to comments by units' owners and discussion of those comment about any matter affecting the community. Except in emergencies, no action can be taken upon a matter raised unless the item is specifically included on the agenda. **A time limit of 3 minutes is allotted per owner.**
