FROM THE BOARD...UPDATES ON THE STRATEGIC PLAN & AMENITIES



Welcome to your Arrowcreek Newsletter. In this issue, I would like to give a snapshot of the areas that were highlighted in our Strategic Planning process as needing improvement. These areas are grouped into: Resident Club, Road/Infrastructure, Landscaping, Trails/Walking Paths, and Pools/Spa. In this article, I will address the Resident


Club, Trails/Walking Paths and Pools/Spa and leave Roads/Infrastructure and landscaping for a later time.

I'll touch briefly on the initiatives that your Board and our General Manager and his team have underway. The initiatives are a combination of ongoing improvements and some exciting new ideas. The graph is from the Town Hall presentation of the results of Hansford Consulting's work over the last 6 months.

Which HOA amenities or services need the most improvement? (Rank top 5)





No surprise in the results - the Resident Club rated the highest priority in the requests for improvisent.



In initial discussions with a commercial architect who has done extensive work in Arrowcreek, we were advised to <u>not</u> expand the existing footprint of the Resident's Club (the picture is an overhead view of the existing facility). The building is not well designed for a footprint expansion and a costly renovation would not achieve our goals of better serving the Resident. Furthermore, any meaningful expansion of the existing building would:

- Entail raising the roof line which would change the views for the existing Resident
- Close the pools during a portion of the construction owing to demolition of a part of the existing building and reconstruction
- Close the entire Resident Club for the year it would take to complete the building process

So instead, we are considering a bold path. To avoid most of the above issues, we are exploring expanding the Resident Club by building an addition located at #1 below. The addition would be seamlessly connected to the existing facility. The proposed structure would be a two-story combination of fitness club and group function/meeting room/kitchen. The fitness club would be built for cross fit training, group training and a cardio studio in addition to the traditional weights and resistance machines. The addition's roof line would be at the same height as the existing building to avoid disrupting views. By building additional space first, we would keep the existing facility open during construction.

We are looking at this area for the expansion.

RSVP to Kate: acpickleball@gmail.com or (408)499-3377 Ed Lahr, our new General Manager, and the ACHOA Operations Team are working to develop an initial Request for Proposal (RFP) for design and construction. We already budgeted (for 2017) the funds for the architectural and design work. The Board wants to get costs for several different structural improvements to the Resident Club. If we move forward with the expansion, phase 2 would be to renovate and repurpose the existing facility with a goal of making it more useable. Office space would be improved; studios could be included as well as billiards/pool, table tennis and other year-round activities. The basketball court would need to be relocated.

In addition to moving the basketball court, we are also exploring building a new indoor lap pool and spa. The lap pool could be attached to the Resident Club expansion. The pool could also be used for water aerobics. The pool could be in area #2

Area #3 could be used for an indoor sports court including striping for tennis, basketball, badminton, volleyball and pickleball.

The walking paths and trail network are also receiving a lot of attention. We are moving forward with our first trail expansion and Parkour course adjacent to the existing multi-use field at the Resident Club. The existing field and turf are due for renovation to fix the issues we have with the sprinkler system and the way the field drains. The early plan is to expand the field with the addition of the course and tackle the drainage issues. We want to keep as much of the turf area open during the regrading/irrigation work as possible. The course will follow the contour of the boundaries of the field. The following shows initial ideas for the types of activities we will include in the course. Most of the obstacles will be decidedly low tech given our weather!! We are also planning a walking path around the field.

Types of obstacles we are considering for the course:



Another thought would be to build a "pump track" like one just built next a park in Truckee

Truckee Bike Park:





A pump track is a continuous circuit of dirt rollers, berms, and jumps that loops back on itself, allowing you to ride it continuously. Pump tracks are set up that, if the track is designed well and you are riding it correctly, should allow you to gain and maintain your speed through the track without pedaling at all. One area we could utilize is off High Vista and close to Harbottle Park. There are roughly 20 acres of flat area in this parcel of HOA common area. There is an existing access road. The course could take up as little as 1-2 acres. The course would be designed for use by all ages.

The pool and deck are scheduled for renovation. We had planned the work for the fall of 2017, but our pool contractor advised us to wait until the spring. The plaster work would be ruined by an early freeze. In addition, we are making plans to expand the pool deck area by moving the fence closer to the Resident Club. This is a relatively painless and low-cost method of providing relief for the overcrowding on the deck.

The Ops team will reconfigure the fence line "south" and away from the Resident Club. The entrance security system will be maintained. By moving the fence, we don't disrupt the current deck area and expand the useable space at the pool for our Residents. Please excuse Google maps for having the wrong title

The ACHOA Documents Committee is currently reviewing homeowner comments concerning proposed changes, revisions to and replacement of the outdated ArrowCreek Bylaws and CC&Rs.

The Bylaws are the documents which govern the

workings of the homeowners' association. The revised CC&Rs will substitute for the current outdated CC&RS and will attach, as will the revised Bylaws, if approved by 50% plus one of the owners, directly as "restrictions" on your property. The time for providing comments to the Committee has been extended to June 15, 2017. Both current and proposed ACHOA documents, as well as an overview of proposed changes, can be accessed through the Associa web site. A formal vote on the proposed documents will be taken from all ArrowCreek owners later this year.

WITH WARM WEATHER COMES FUN POOL TIME!



The pools, sport courts, resident club facility and all the ArrowCreek HOA (ACHOA) amenities are available for all ACHOA residents to enjoy. We hope you have a GREAT summer! For safety and harmonious enjoyment, please keep in mind the following:

- You must be an ACHOA resident or be a guest with the resident present to use the ACHOA facilities. Staff will be working to enforce this policy by spot checking and viewing keycards. Residents and guests may also be asked to sign in and show their keycard. Please help, if you become aware of someone using the facilities who does not belong there, and/or are doing something against the rules, please alert ACHOA staff immediately. If no staff is present, call security! We very much appreciate everyone's effort to keep a safe and friendly environment.
- The pool & spa gates must remain closed always. Please do not prop open access gates as it violates a health regulation in Washoe County and poses a danger to our young residents.
- Remember, the ArrowCreek HOA Residents' Club is a *swim at your own risk facility*. There are NO LIFEGUARDS ON DUTY!
- Pools & Spa Hours of Operation: 5:00am 10:00pm
- Closed Daily: 8:00am 9:00am for maintenance
- Pools: Children 14 and under must be accompanied by an adult (18 or over) to swim.
- Spa: Children under the age of 8 are not permitted in the spa (per Washoe County Health Department).
- Spa: Children 8-16 years of age must be with an adult (18 or over)
- FOOD IS NOT ALLOWED PAST POOL & SPA GATES.
- NO GLASS CONTAINERS ALLOWED IN THE POOL OR DECK AREA! Broken glass in the pool or deck may cause the pool to temporarily close.
- INCLEMENT WEATHER POLICY Facilities may be immediately closed in the event of an electrical storm. Individuals are to exit the pool and spa immediately when lightning/thunder are detected or upon the order of a member of the Residents Club staff, or a member of the ArrowCreek security staff.

Note: Patio & Deck Umbrellas must be closed before you leave the area. Strong gusts of wind may cause irreparable damage. IF THERE IS AN EMERGENCY AT THE POOLS OR SPA CALL 911. The full set of pool rules are posted at the Residents Club and are available on the HOA website.

WILDFIRE AWARENESS EVENT HELD IN ARROWCREEK – GREAT SUCCESS

May was an important month for ArrowCreek residents. Why? Because May was Wildfire Awareness Month in Nevada! And, it's critical for everyone in ArrowCreek to know more about how wildfires can affect



lives on a moment's notice. To address wildfire concerns, the ACHOA and the Club at ArrowCreek in conjunction with Washoe County helped more than 125 ArrowCreek residents improve their Wildfire IQ on Sunday, May 21 up at the Club at ArrowCreek.

Personnel from Truckee Meadows Fire Protection District, Nevada Division of Forestry and the US Forest Service explained to attendees what their agencies do to fight wildfires. Homeowners were given information by these agencies on how to prepare for wildfire and what to do if one occurs near their home. While parents were gathering information, many children had a great experience of sitting in the various fire trucks provided by the three fire agencies.

Washoe County Regional Animal Services talked with people and provided information about how to prepare to evacuate a pet for a potential stay in an evacuation center or hotel. Staff from Living with Fire brought their Ember Aware house to help homeowners understand how to protect a home from flying embers, which are the most likely source of fire in a home or other structure during a wildfire.

The Fuels Management and Safety Committees provided several sources of information in the form of evacuation maps and checklists, emergency planning, resources about insurance, helpful websites and apps for the phone. Information on plants, trees and bushes to plant to create defensible space around homes was also available for everyone.

A great lunch including delicious hamburgers, hot dogs and fixings were provided by the Club at ArrowCreek, courtesy of the ACHOA Social Committee. The ArrowCreek Archer, which did a wonderful job advertising the Wildfire Awareness Event, also provided raffle items given to four lucky residents.

The highlight of the day was the appearance of Smokey the Bear, who will be 73 years old in August. Smokey, who pleased children and adults alike, enjoyed giving the little ones "high fives" during the event.



Many of the handouts from the event are available at the Resident's Center. We encourage you to pick up this information focused on wildfire awareness if you were unable to attend the event. As we stated at the beginning of this article, it's important to be prepared just in case of a wildfire in this community.

Resident Club Access Policy

We can understand how frustrating it can be when there are a lot of residents using the ACHOA pool and facilities. We wanted to share with you the HOA policy so that you would know what the HOA does to try to manage use of the Residents Club.

There is a system in place, for both security and the residents club, to delete transponders and Resident Club Key Cards on properties that have sold and/or for tenants who have moved out. The policy for use of the resident's center is that you must be a resident or be a guest with the resident present. Staff does try to enforce this policy. The ACHOA has seasonal pool monitors on staff. They are usually scheduled during the busiest pool times; typically, noon to 5 or 7 PM. Last year we implemented the following additional protocols to help with the non-resident use concern: 1) The pool hosts randomly spot check guests too view their key cards, and 2) Pool hosts are scheduled to sit by the gate with a sign in sheet so they can inspect keycards. If you become aware of someone using the facilities against the rules, please alert staff directly so that we can investigate immediately. We very much appreciate everyone's help to enforce this.

For additional information, the Resident Club Policy & Procedures are posted at the Residents Club, and on the ACHOA website. Enjoy the facilities!

NEW RULE!

ACHOA - UPDATED RULE - SCHOOL BUS PASSING. A notice was recently sent to all ACHOA owners that at the 4/18/17 meeting the Board passed rule language to clarify that vehicles must stop for a school bus when its lights are flashing even if you are on the opposite side of a divided road. Though this is new to the ACHOA rules, the language is adopted from the Nevada state traffic laws and is almost verbatim of the Nevada Revised Statutes (NRS) governing vehicles on public roadways. The new rule is included below. A full



set of Rules is posted on the ArrowCreek-hoa.com website and is available upon requests from Associa Sierra North.

We want to remind everyone to be cautious while driving in the community; please, stop at stop signs, do not speed, do not tail gate and stop for school buses when the lights are flashing. Let's keep everyone safe!



ADDED 4/18/17:

Overtaking and passing a school bus: Duties of driver; exceptions; penalties.

- 1. The driver of any vehicle when meeting or overtaking, from either direction or on a divided section of an ArrowCreek road way, any school bus equipped with signs and signals required by law, which has stopped to receive or discharge any pupil and is displaying a flashing red light signal visible from the front and rear, shall bring the vehicle to an immediate stop and shall not attempt to overtake or proceed past the school bus until the flashing red signal ceases operation.
- 2. The driver of a vehicle need not stop upon meeting or passing a school bus where traffic is controlled by a traffic officer, security officer and/or school bus driver.
- 3. Any violations of the provisions of this section may be considered a health & safety violation with penalties exceeding \$100 commensurate with the violation as determined by the executive board in accordance with the governing documents. See NRS 116.31031 and NRS 484B.353.

Sign Up for Regional Alerts

Regional Notification System - Code Red

If there is a fire emergency in ArrowCreek, or in our area, will you get the message? Washoe County has partnered with the Cities of Reno and Sparks to institute a telephone



notification system for use in times of crisis. The system is known as "Code Red." The "Code Red" system will reverse dial land line phones with listed numbers to send out a message regarding emergency situations including evacuation recommendations. However, unlisted phone numbers and cell phones are not included in this reverse calling system UNLESS you sign up.

Wildfire situations can rapidly develop and neighborhoods many need to be evacuated rapidly. (If you were living here during the Caughlin Ranch Fire in November of 2011, you probably received a 5:30 AM call from the Code Red system on your land line phone.) By getting a Code Red phone call to your home phone, cell phone, unlisted land line, or even your work phone number, you can make your evacuation plans earlier. You can also sign up to receive text messages and/or e-mails.

When a crisis occurs, local public safety officials have three methods to alert the public:

- 1. Media press releases to local radio, television, newspapers, and government webmasters.
- 2. The Emergency Alert System (EAS). Messages are rebroadcast on radio and television.
- 3. The Code Red Notification System. This system uses a series of remote computers and telephone lines to relay a recorded message.

While no system can ever be guaranteed to be disaster proof during the chaos of an emergency and unforeseen circumstances can make some modes of communication inoperable, Code Red can help you keep in the know regarding wildfires. Sign up at https://www.washoecounty.us/em/RegionalAlerts.php or type "CODE RED WASHOE COUNTY on your web browser to link to the Regional Alerts page. A few minutes now could be critical in the event of a future wildfire.

EARTHQUAKE AND WEATHER ALERT SYSTEMS

 Earthquakes - The Nevada Broadcast of Earthquakes (NBE) is an experimental earthquake warning and response system. NBE is a project of the Nevada Seismological Laboratory at the University of Nevada, Reno. The system is designed to list measurable earthquakes, with an attached map detailing the location of the earthquake. This listing shows all earthquakes throughout Nevada.

Citizens can log onto the Nevada Seismological Laboratory, <u>Nevada Broadcast of Earthquakes</u> or call 775.784.4975 to learn more about seismic activity in their region.

- weather Citizens can register for severe weather alerts through the National Weather Service. These alerts are designed to help citizens prepare for major storms that are forecasted to affect our region. The Emergency Email and Wireless Network provides breaking weather forecast news directly to email accounts, with links to the relevant radar maps. Log onto The Emergency & Wireless Network to register.
- ALERT ID SIGN UP THE WASHOE COUNTY SHER-IFF'S OFFICE IS IN PARTNERSHIP WITH ALERTID. ALERT ID IS A FREE ONLINE WEB SERVICE TO PRO-TECT YOUR FAMILY AND YOUR NEIGHBORHOOD.

Alert ID uses online technology to create instant, two-way communications between citizens and federal, state, and local authorities to provide immediate information on crime, terrorism or natural disasters that can threaten the safety of your family and community.

Using the unique Alert ID system, you are constantly connected to neighbors, local police and fire departments, as well as federal and state agencies to exchange critical information that can help keep your family and community safe, whether the threat is national, local, or personal such as a missing child or family pet.

• A Note about "Voluntary Evacuations" - "Voluntary Evacuation" Orders are the only evacuation orders that are issued by County officials and should be taken seriously.

Once you receive notice of a voluntary evacuation order, prepare for evacuation. If the threat is not in our immediate area, monitor local news reports and prepare for evacuation. Be ready to evacuate at any time and seriously consider evacuation upon receiving voluntary evacuation order. Signing up for CODE RED will help to ensure that you are aware of crisis situations and the need to evacuate as soon as possible.

The Governor is the only state official authorized to issue a "Mandatory Evacuation" order. Do not wait to receive a Mandatory Evacuation order before deciding to evacuate your home. When you do leave your home,

- 1. Leave your doors unlocked,
- **2.** Close your garage doors (you may have to manually close the doors if there is a power outage), and
- 3. Post an EVACUATED sign in a prominent place so disaster officials are aware that you have left your home.
