PRESIDENT'S MESSAGE

NEW MAGAZINE FORMAT

We hope you enjoy the new format and extra content in this community magazine. The HOA Communications Committee, Social Committee and Board members worked hard to forge a contract with a private publisher that brings this handsome publication to all residents without incurring any production or distribution costs. This is possible by allowing the publisher of ArrowCreek View to include advertisements. Some residents may feel ads are inappropriate in our HOA magazine, but a very good arrangement was struck with the publisher. Our contract guarantees substantial HOA editorial and style control and gives the HOA authority to reject any advertising we deem inappropriate.

2019 HOA BUDGET

As I write this Letter, the Budget Committee has completed its fourth draft of a 2019 HOA Budget. By the time you read this, a community forum presenting that Budget will have taken place. The Budget Committee and the Board seriously cut elective projects. The Board also remains aware that an assessment increase was made last year. Half our Operating budget goes to staff salary and benefits. You have seen jobs go begging all over Reno and across the USA this year. That has put considerable upward pressure on all wages. General Manager Scott Peterlin was unable to hire additional landscape workers this Summer because he couldn't offer today's market wages without distorting our current staff pay scale. Of course, Scott keeps pushing for higher efficiency by adjusting crew assignments and acquiring productivity tools. But a staff of 5 and two working supervisors can only do so much in

a community as large and self-maintained as ArrowCreek. We need to raise 2019 salaries to both retain and hire staff.

COMMUNITY IMPROVEMENTS

The 2019 Budget proposes to spend about 4% of our operations cost on community improvements. These include fire evacuation enhancements; the first-ever upgrade of equipment at the Residents Center playground; wide-area walking trail maps and signage; and low-cost improvements to our sports courts among other items. Most Board and Budget Committee members want to see ArrowCreek remain the class community it is today... and to retain the real estate cachet it enjoys today. That requires at least this modest commitment to improving our physical plant.

Higher staff and materials costs plus spare community improvements can be accommodated if 2019 assessments rise by the inflation rate, which our crystal ball puts in the \$5 to \$10 /month range. A final figure will be set after the Board takes resident input into account.

Your HOA Board welcomes your ideas, constructive criticisms and volunteer participation in ArrowCreek governance. Write to us, c/o Jeanne Tarantino our Community Manager, at ACService@ AssociaSN.com. CAN YOU CLARIFY THE DIFFERENCE BETWEEN THE WEBSITE, TOWNSQ, VOLO VILLAGE, & QUICKPASS AND WHY WE NEED DIFFERENT LOGIN/ PASSWORDS FOR EACH?

Great Question! Over the last year there have been several changes made to provide better communication within the ArrowCreek Community. Below is a bullet point clarification of each tool and how they work. Hope it helps!

Website (www.arrowcreek-hoa.com)

The current website is set up to be completely public, meaning that it does not require any logins or passwords. The website is created with the intent to provide HOA information to all residents, owners and tenants alike, as well as to real estate agents and potential buyers. The ACHOA has been in process of building a new website, which may be out by the time of this publication. If not, it will be out soon. There has been a temporary website up and running until the new site is ready. The website also links to TownSq.

TOWNSQ (www.townsq.io)

This is the new Associa platform to manage HOA Communications. This is a secured platform for owner use. Note, all owners should register for TownSq using your account ID#. By registering and creating a login/password in TownSq you will have real-time access to your account to view the status of assessments, payments, charges, violations, work orders and architectural submittals. You can also make payments online. Through TownSq owners can send any question or comment to the HOA. Announcements are posted that will automatically be emailed to you to keep you informed. HOA documents are posted on TownSq that include secured documents such as minutes and financials that are not available for public view. TownSq is available for Android and iOS. You can download the App and have account and HOA information accessible on your phone!

Volo Village (http://portal.volorecovery.com)

Owners are automatically registered in the secured Volo Village third-party program using the contact information you provide to the HOA. Volo is a communication tool to send emergency information and quick important announcements usually via text and phone calls. For example, it was used during the road replacement project to keep owners updated on the work schedule. Though owners are automatically registered, each owner can update their contact information (where they want to receive information) by logging into your Volo account. Contact the HOA at ACservice@ associasn.com if you need a Volo password.

QuickPass (https://www.QuickPass.us)

Owners need to register for this secured site. QuickPass is the gate entrance program used by the ArrowCreek Security Gate. This third-party secured system requires a password. All residents should register for Quickpass to set up your visitor instructions. You can also provide security with special instructions or alerts you want them to be aware of. For example, "Do not allow access to Jane Doe".

DESIGN & REVIEW COMMITTEE (ADRC)

The ArrowCreek Homeowners Association, Inc. Architectural Design and Review Committee ("ADRC") is an Association Standing Committee created by the Association's Declaration of Covenants, Conditions and Restrictions (CCRs). [Articles V & VI] This important committee is responsible for reviewing and approving all proposed exterior improvements to a lot owner's property and dwelling as well as any Association owned common elements. The committee is set up to maintain the integrity, architecture and uniformity of the subdivision and are required by the CCRs to make all final decisions regarding any lot owner's request for improvement or change to any properties. To further assist Owners with ADRC decisions they may not agree with, the ADRC has set up an Appeals Process to include Board of Directors guidance. This process is a courtesy now but would be mandatory if the revised CCRs are approved. The revised CCRs would also require a final approval from the Board of Directors for any ADRC Guideline changes which are currently the full authority of the ADRC.

Until such time that the Governing Documents may be approved, the ADRC has been making positive changes to become more responsive and accommodating to lot owner requests. The first significant change that occurred several years ago involved making the ADRC an organization run by your fellow lot owners and not controlled by the vendor architects and engineers on the committee. During that time perimeter split rail fencing requirements that had been established by the Developer were changed due to Owner input to allow more flexible fence placement. The original development and publication of the Architectural Design Guidelines has been updated with numerous edits and changes over the years to help provide Owners with more clarity for submittals.

Lately, the ADRC has been working to improve the ease of the submittal process and requirements especially for minor projects. An updated format of the document and submittal application is in the works. A flow chart is being designed to easily guide Owners through the submittal process. The current ADRC Committee members are dedicated to improving the process and improving communication with the community at large. Our beautiful community has been the result of their dedicated volunteer service to the community. It's a difficult task at best to follow the standard building requirements dictated by the governing documents and to accommodate the wants and needs of each Resident. They are some unsung heroes and heroines within our community. Thank you to our ADRC members who are working to make the process more user friendly for everyone: John Krisch (Chair), Morgan White (Board Liaison), Dave Steele, Roger Sheppard, Tricia Leonard, Ron Duncan and Charlie Dickinson.





MONEY MATTERS

ARROWCREEK HOMEOWNERS ASSOCIATION BUDGET & FINANCE COMMITTEE REPORT

The members of the Budget and Finance Committee have been working on the Draft 2019 Budget since June of 2018. The Committee accumulated information from all other advisory committees concerning expenses and plans for 2019 that would require funding. Staffing requirements were reviewed and capital purchases were reviewed during the development of the 2019 Draft Budget. A Budget Workshop was held at the Residents' Center on October 9th to discuss the 2019 Draft Budget with interested community members. Feedback was presented by the community and the Budget and Finance Committee included the feedback into the final proposed draft 2019 Budget. The Final 2019 Draft Budget was proposed for Board approval at the Board meeting November 6, 2018.

If the Board approved the Final 2019 Draft Budget, the 2019 Budget will be ratified at the ArrowCreek Homeowners Association Annual Meeting on December 11, 2018. The Budget and Finance Committee would like to thank all Association volunteers for their input into the development of the 2019 Budget.

SUBDIVISION COOPERATION

The ArrowCreek Common Interest Community has two dynamic operating entities that economically strive to cooperate with each other to generate joint benefits that enhance this positive, dynamic community. The commitment of The Club At ArrowCreek to become a premier family membership golf resort and the commitment by the ArrowCreek Homeowners Association, Inc.'s ("ACHOA") governing board to maintain, enhance and improve on community amenities will drive our common interest in maintaining and increasing our home values.

Over the years the resident owners of The Club At ArrowCreek have demonstrated their passion for the ArrowCreek Community. They have demonstrated a commitment to the goals of our common interest community through investments in The Club At ArrowCreek and the shared services provided to the ACHOA. This symbiotic relationship enhances the value of our homes and property for all Arrow-Creek stakeholders. The Association has directly benefited through this relationship by lowering costs for provided services to our lot owners.

Services from The Club At ArrowCreek that benefited the ACHOA include:

- Providing use of the drainage area called the "pit" without cost to our facility team to provide equipment storage areas, recycling biodegradable plant materials for reuse with our landscape plantings, and a staging area for numerous landscape projects through out the years;
- Providing a driveway easement for access to ACHOA maintenance building and storage area for years without cost;
- Providing storage within its Maintenance Building for facility team's equipment without a cost;
- Providing access to its equipment mechanics at reduced costs to repair facility team's equipment saving ACHOA money;

- Providing access to the above ground fuel tank for the purchase of fuel at its cost for all ACHOA vehicles and facility team's equipment saving ACHOA money;
- Providing repeated access to meeting rooms and large dining area for large Board and Homeowner Town Hall meetings without cost;
- Providing food service for ACHOA social events including year-end Holiday Party at discount prices saving money for the ACHOA;
- Allowing Association Lot Owners access to golf course land to reduce fire fuels adjacent to their home with no costs or obligations to the lot owners;
- Continuing to pay their equivalent lot monthly assessments as per the governing documents;
- \cdot Agreeing to pay for a portion of the 2017 Fuel Reduction Grant to reduce wildfire plantings within its 524 acres; and
- Maintaining the best single ACHOA Community firebreak through its vibrant 36-hole golf courses that run throughout our Subdivision.

The ACHOA provides snow plowing for The Club At ArrowCreek parking lot in exchange for allowing the snow removal vendor to store equipment at The Club At ArrowCreek maintenance yard. The ACHOA provides security access for non-resident members of The Club At Arrowcreek and offers for sale Quick Pass transponders for access. The ACHOA works with The Club At ArrowCreek to expedite entry into the community for Golf Tournaments. The ACHOA provides full access for all golf course equipment to golf course entry points using ACHOA roads, walkways and paths.

The Club At ArrowCreek and the ACHOA have a common history and a common interest to maintain home values within the community. This cooperative shared interest of the two operating entities within our community creates at times a seamless and efficient operation. This is an important hidden attribute for the Arrowcreek Common Interest Community. Like a lot of residents, the exceptional beauty of the Western United States and the Reno Valley drew us here. We came for the view, but we stayed for the growing dynamic common interest community behind our gates.

The golf course survived two ownership changes. One change was created through a bankruptcy prior to the current forward-thinking management of The Club At ArrowCreek that is now committed to enhance the experience of a family-oriented golf resort. The future changes at The Club at ArrowCreek are welcome and important to the longevity of the entity. These planned enhancements along with the changes and improvements within the community by the Association will further our home values. All these positive changes and new amenities will benefit and enhance our common interest community and make it a desirable place to live. Keep watching as changes develop over the years.



GOVERNING DOCS

GOVERNING DOCUMENT APPROVAL VOTE

The Proposed Governing Documents which include the Declaration of Covenants, Conditions and Restrictions ("CC&Rs") and the Association Bylaws are moving closer to approval. The Board would like to thank all that have voted since July 2017 and ask that those that have not voted to take the time to cast your vote. The Goal is to have over 90% participation in the vote and we are still short with approximately 300 Ballots yet to be received. The voting closes when 50% plus one (545) lot owners either accept or reject the revised documents.

The CC&Rs and Bylaws refer to each other, and as such there is only one vote for both governing documents – YES

or NO. Ballots can be received by email at ACservice@associasn. com. Ballot Votes may be sent through email, U.S. Mail or hand delivered to Associa Sierra North or dropped in the Ballot Box at the ArrowCreek Resident's Center. All Ballots received automatically enters the lot owners name into the association drawing for a \$250 Visa Gift Card. PLEASE VOTE!

Note: The CC&Rs and Bylaws (current, revised and redlined versions), together with the ballot are posted on both the www.arrowcreek-hoa.com website and on TownSq for easy access.



RESIDENTS' CENTER KEY CARD UPDATE

At the request of many Residents and the approval of the Board of Directors, your key cards are being updated. We are

doing this to help eliminate guests using the amenities without the Resident being present. The new key cards will have a picture of the Resident, so our pool hosts can quickly verify the card holder.

Please sign up at the Residents' Center to get your new card. ALL cards must be converted by January 1, 2019. Also. . . if you haven't voted for the New CC&Rs yet, you can pick up your form while getting your key card made.

RESIDENTS' CENTER CURBING

The curbing at the Residents' Center loop and partway up the street was painted red (No Parking) for safety reasons. After a review with the Fire Department it was determined that allowing vehicles to park along these areas blocks Emergency Vehicle access. I would like to thank everyone for their understanding and cooperation.



NEW BUS STOPS ADDED

Three new bus stops were added at the corner of Winding Ridge and AC Pkwy, Winding Ridge and Masters Drive and Masters Drive and Harbottle Drive. We added signage and crosswalks to all bus stops to ensure the safety of our children. Since these bus stops are new, we would like to ask all residents to please take extra precaution while driving through these areas, especially while there is snow or ice on the ground.

SNOW AND WATER EVENTS

Contact ArrowCreek Security at 775.850.4450 with all snow removal and drainage flooding concerns.

Snow Removal

Residents are asked to be PATIENT with the Snow Removal Program. It can take 18+ hours to clear and sand all roads within ArrowCreek depending on the type and amount of snowfall. Scott Peterlin, General Manager, and Rick Reyome, Security Director, have met with Q&D (the snow removal vendor) to discuss the snow removal process: what has been working well, and what can be done better. Q&D is working with the ACHOA to address what can be done better as we move forward. Please take note of the following:

- Q&D will make single passes to open road ways for emergency vehicles. They will come back later to clear the rest of the road.
- When the snow falls fast and hard, Q&D may not be able to get back to your property for additional clearing as timely as usual. Please be patient and stay home if you can.

- Snow berms come with the territory and are the resident's responsibility to remove at the bottom of the driveway. Q&D will attempt to minimize snow berms in front of driveways when they can. Please note that there are no guarantees that once a resident clears their driveway that a snow berm will not appear due to snow fall and snow removal priorities within the community. And, when the snow is falling fast and hard, Q&D may not be able to get back to clear as timely as usual.
- * Q&D is sanding the roads. But, when the snow comes down fast, it covers the sand very quickly, and the roads may remain icy and slippery. Use caution. Don't be out driving if you can avoid it.

MEDICAL CONCERNS

Medical Concerns - Residents with any medical issues or concerns should notify Security so they may be put on a priority list. Please let security know if you have any current medical concerns!

MAIN GATE REMINDERS FOR THE HOLIDAYS

I would like to wish everyone a Safe and Happy Holiday Season. With Holiday parties and get-togethers just around the corner, I would like to remind everyone:


- » ArrowCreek can get very busy during the Holiday Season. Security would like to ask you to please call in your guests or add them into the QuickPass System yourself to avoid unnecessary long lines entering at the main gate.
- » Make sure Security has your current phone number – We would hate to turn around your guests if we can't reach you.

AAA

- » For the residents living behind the inside gates, when needing the gate held open for a party or event, there is a 2-business day notice required. Security will be willing to meet the request of parties of 5 vehicles or more only. Security will try to meet your request if an unexpected event occurs with less than 2 days notice. Sometimes it will just not be possible.
- » Please have all your guests park on the same side of the street. We need to keep a lane clear in case of an emergency.

RADAR CAMERAS AND STOP SIGN CHECKS

Security would like to thank the Residents for their cooperation in continuing to lower the overall speed and reduce stop sign runs throughout the community. Security continues to remind visitors that



the speed limit is 25 mph, which seems to be helping reduce speeding violations amongst guests. You may have noticed Security parked at Stop Signs throughout our community several times a day. We have seen a dramatic decrease in Stop Sign Violations and we are able to reduce Security's patrols for the time being. If you notice a violator, please take note of their license plate, and which Stop Sign. Under no circumstance do we condone you taking matters into your own hands, report to security only. Thank you for all your help with this matter.

DID YOU KNOW WE DO VACATION PATROLS?

Are you and your family about to head out for a long vacation? Let us put your mind at ease and ask to be added to our Vacation Watch Patrol. Security conducts 2 extra patrols per day to check on properties while residents are out of town.

The first patrol is done early in the morning: between 5am to 7am. Then swing shift (1pm to 9pm) & graveyard shift will check if needed, by resident call/concern. Security will check for any problems outside of residence that can be seen:

- » Water Leaks
- » Broken Windows
- » Open Doors
- » House Alarms
- » Cars parked in driveway, etc.

By providing us with contact info for your emergency contact/house sitter, we can notify them ASAP if a problem arises.

Residents can stop by the gatehouse and fill

out a Vacation Request Form, or you can email the gatehouse requesting to be added to the list. Be sure to include:

- » Address
- » Dates you will be absent» Best way to contact you,
- if possible
- » Contact info for house sitter/emergency

Transponders

Transponders are not intended/designed to be moved. If you do move a transponder from one vehicle to another, you need to let Security know so the QuickPass System

WILDLIFE ISSUES

ArrowCreek is one of many communities located in "Wilderness Urban Interface" area and, as such, residents may more frequently experience problems with animals, reptiles, and insects in or near their homes or property. **Residents are responsible for any issue regarding wild animal/snakes etc., on their property.** Security staff will assist by giving residents the correct phone number of the agency that may be able to assist them.

HOLIDAY LIGHTING & DÉCOR

The Holiday Lighting & Décor Rule has been updated to incorporate Halloween. The clarified rule is as follows:

Holiday Lighting & Décor (updated August, 21, 2018). Holiday lighting and décor may only be installed for use during the holiday period. Holiday lights must be turned off by midnight. Holiday lights and décor may be installed at a reasonable time in advance of the holiday and must be removed within a reasonable time following the holiday. A reasonable time for Halloween lighting and decor is defined as the month of October and first week of November. A reasonable time for Holiday lighting and decor is defined from Thanksgiving through the month of January. Note: CCRs IV Section 46 unreasonable levels of sound or light are prohibited.

can be updated. If a transponder has been moved and Security sees it is not on the vehicle we assigned it to, the transponder will be de-activated until you bring in the current vehicle's information. Also, if you move a transponder and it does not work, you need to purchase a new one.

- » When you get a new vehicle, used vehicle, or just change your license plate, please contact Security with the updated vehicle information.
- » If you receive a vehicle transponder before your vehicle has been registered, please keep in mind that Security needs a copy of your registration within 30 days or the transponder will be deactivated. If you have a transponder that is not working contact Security.
- » Please remember your dogs must be "walked on a leash" and you must clean up after your pets. Pet Mitt stations and trash cans have been placed around ArrowCreek Parkway. The park at Harbottle and the Resident Center needs special attention with cleaning up after your dogs. Complaints have started to be brought up about residents not picking up after their dogs.
- » There is a lot of construction going on inside the ArrowCreek community. That means there is an increased number of large construction vehicles coming and going from the community. Please be patient with them on the roads and especially when these vehicles are entering at the gates. These construction workers are guests and they must follow the community rules and policies. Please report issues to Security.
- » Motorcyclists, you can use the outside lane when entering ArrowCreek, but your motorcycle must have the Security issued sticker on it for identification purposes.
 Riding around the gate arm is not an acceptable way to enter. The stickers

are free and be prepared to come to a complete stop before Security will raise the arm for entry.

SCHOOL BUS STOPS

There are several Bus Stops along



ArrowCreek Parkway and a few of them have a median. If you see the bus stopped with their "STOP SIGNS" out, even if there is a median, PLEASE stop regardless

which way you are traveling. We have children crossing the road, sometimes in a hurry, and they may not look for vehicles.

We continue asking all residents if you park at a bus stop to please stay back at least 30 feet from the intersection, and all park on the same side of the street.

- » 30 feet (about 2 car lengths) is so cars coming up to the intersection can see other cars, and not block incoming traffic.
- » Same Side of the street is so you are not blocking traffic, and for emergency vehicles access.
- » Arrowcreek & High Vista intersection: No Parking here. There is an area on High Vista & Rue St. Tropez that you are welcome to park at.

Security monitors all bus stops every morning and afternoon and will remind parents to please follow the rules listed above.

The climate! Raising an urban forest in the high desert certainly has its challenges.



INTERESTS AND OR HOBBIES? Hiking, backpacking, fishing among a few others. Just about anything outdoors.

ANY ADVICE FOR PLANTING TREES AS WINTER

APPROACHES? Fall is a good time for planting. Newly planted trees don't have much of a root system and need more frequent watering than established trees. Make sure trees planted in the fall get plenty of supplemental water; often after the irrigation system has been winterized. Checking new trees weekly through dry winter weather is a good idea.

ArrowCreek Pickleball Club in Reno, NV celebrated two years of fun, enthusiasm and a growing membership in October. It all started more than two years ago. One of ArrowCreek's four tennis courts was slated to be re-surfaced in September of 2016. A passionate group of ArrowCreek Pickleball players carried petitions, held meetings dotted with "I love Pickleball" buttons and convinced the ArrowCreek Board of Directors to resurface a single tennis court into four Pickleball Courts.

In October 2016, the ArrowCreek Pickleball Club was formed. It attracted dozens of dedicated players and several local experts who helped teach the growing sport to residents.

When the weather changed in November, and the players had trouble holding paddles with their gloved hands, the group turned to the Club at ArrowCreek, which allowed the dedicated Pickleball group to use its permanent tent. ArrowCreek residents likely remember that difficult winter. It was the coldest and wettest in memory. Although there were heaters in the tent, the moisture and cold created challenges. The diehards kept playing, what they affectionately termed the ArrowCreek Slip and Slide in the tent.

A few months later, the golf club owners and the HOA joined forces to allow Pickleball players to use both facilities at the golf course and the HOA Pickleball courts. In spring, the group created an ArrowCreek Pickleball website, www. acpc.clubexpress.com and now has over 90 members with dozens more supporting the sport through tournaments and meetings. Several players competed and won medals in the Reno Senior games.

Open Pickleball play occurs almost every day when the weather allows. All homeowners and members of TCAC are invited to the open play, which is updated daily on the Pickleball website.

ArrowCreek resident Kate Whittley led the campaign to establish Pickleball in ArrowCreek. She currently volunteers her time to give private and group lessons to anyone who wants to learn. She keeps a stash of extra balls and paddles so that any ArrowCreek resident who wants to give it a try can discover Pickleball. 



Wildfire YOU ARE THE FIRST LINE OF DEFENSE

The last two years have proved to be significant summers for wildfires. Truckee Meadows Fire Protection District (TMFPD) responded to twice the number of fires since 2016 and suppressed more than four times the amount of acres burned than in previous years.

In 2017, the wildfire season began in June and continued through December. During the first week of July alone, 23 fires broke out burning 140,000 acres. A total of 360,000 acres burned in Washoe County that year.

The wet winter of 2017, coupled with this past spring, is largely attributed to a robust growth of fuels; particularly fine fuels such as cheat grass. In fact, wildland fuels in western and northern Nevada are now 200-300 percent above average in many areas, a dangerous recipe for a wildfire.

Earlier this summer, the Perry Fire in Palomino Valley is alleged to have been started by fireworks. The fire burned more than 51,000 acres and destroyed two residential structures. The experience in our neighboring state to the west has of course, been much worse.

I urge you to be the first and best line of defense against wildfire by creating defensible space around your home. Defensible space is essential to improve your home's chance of surviving a wildfire. It's the buffer you create between a building on your property and the grass, trees, shrubs, or any wildland area that surround it. This space is needed to slow or stop the spread of wildfire and it protects your home from catching fire—either from direct flame contact or radiant heat. Defensible space is also important for effective fire suppression and the protection of the firefighters defending your home.

Creating an evacuation plan is also essential. There are plans you can undertake both inside and outside your home in the event you need to evacuate. Plan ahead. Developing a plan at the time of a fire is too late. Truckee Meadows Fire staff is available to consult with our



residents at no charge to help with plans to create defensible space and pre-evacuation preparations.

I'm often asked about open burning. Open burning is restricted to a significant degree. Owners of agricultural lands and backcountry areas rely on pile burning, but it is in our community's best interest to minimize pile burning through alternatives. TMFPD's Green Waste Program is designed to increase safety by minimizing open burning and air pollution - and provide you an easier and less costly alternative than trips to the landfill. This November, TMFPD will again support your efforts to create defensible space by accepting your harvested green waste free of charge. Last year, we collected and masticated over 1000 tons which was then recycled into compost.

Today's wildfire reality is a longer and more intense season. This trend will continue. Risk reduction will be enhanced with partnerships, not through emergency response alone. TMFPD is committed to serving and protecting you and your family, and working with you to help you become the first and best defense from a wildfire.


